

The admission process for the Master's programmes taught in English, for foreign citizens, includes the following stages:

- a) online submission of the application file to DCU at the e-mail address [admitereudc@gmail.com](mailto:admitereudc@gmail.com), between 1 September and 10 September 2026;
- b) verification of the application files by the Admission Committee;
- c) online interview, according to the schedule established by the Admission Committee and communicated to the candidates;
- d) completion of the procedure for recognition/acceptance of previous studies, according to the candidate's citizenship status:
  - for citizens of EU Member States, EEA countries and the Swiss Confederation, as well as other categories covered by the applicable legislation - recognition/equivalence of previous studies by CNRED;
  - for citizens of third countries (non-EU) - submission by the University of the files of admitted candidates to the Ministry of Education for the issuance of the Letter of Acceptance to Studies.

Admission application fee for the September 2026 admission session - EUR 100

Application processing fee for foreign candidates - EUR 100

The annual tuition fee for each Master's programme taught in English is EUR 3,000. For the two-year study cycle, the total tuition fee is EUR 6,000. The annual fee is payable upon enrolment in each academic year.

### Fee payment procedure

Candidates applying for admission to DCU in the 2026 session may pay the admission application fee, the application processing fee and the tuition fee using one of the following methods:

- (1) By bank transfer / internet banking to the following account:

RO72BACX0000002583530001 (UniCredit Bank)

Candidates must include the following information in the payment details:

Beneficiary - DCU; payment details - type of fee (admission fee / processing fee / tuition fee), study programme, candidate's surname and given name(s), exactly as stated in the application form.

**Very important: The payment order must contain the details of the admission candidate, not those of the person making the payment, if the payer is other than the candidate.**

Example: Master's Admission Fee: Smith Mary Jane

- (2) In cash or by card at the cashier's office of Dimitrie Cantemir University, daily between 08:00 and 14:00.
